ANSON H. STAGE and LUCIE T. STAGE  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of SIXTY-EIGHT THOUSAND AND NO/100THS----- DOLLARS

(\$ 68,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

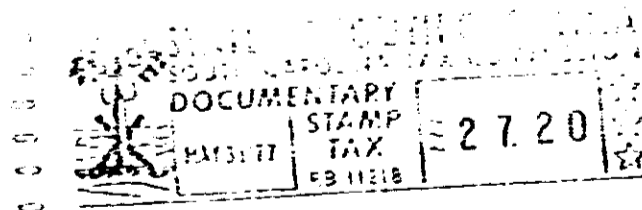
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot #35 of Stratton Place Subdivision, according to plat prepared by Piedmont Engineers and Architects dated July 10, 1972 and recorded in the R.M.C. Office for Greenville County in Plat Book 4-R at Pages 36 and 37, according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Whittington Drive, which iron pin is the joint front corner of Lots 35 and 36 and running thence N 64-05 W, 170 feet to an iron pin; thence S 25-55 W, 120 feet to an iron pin; thence S 64-13 E, 166.15 feet to an iron pin, the joint front corner of Lots 35 and 34 on Whittington Drive; thence along the northern side of said Drive N 37-00 E, 20 feet to an iron pin and continuing along said Drive N 25-55 E, 100 feet to an iron pin, the point of beginning.

This is the same property conveyed to the Mortgagors herein by deed of James M. Polito and Giovanna R. Polito dated May 31, 1977 and recorded herewith.
