TO ALL WHOM THESE PRESENTS MAY CONCERN:

Robert A. Legrow and Karen D. Legrow

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-five Thousand Seven Hundred and no/100-----DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 27 on plat of Broadleaf Forest, Property of Leslie & Shaw, Inc. recorded in Plat Book MM at page 64, and having according to said plat, the following courses and distances:
