(with interest thereon from Dec. 2, 1977 at the rate of six (6%) per centum per annum, to be paid monthly

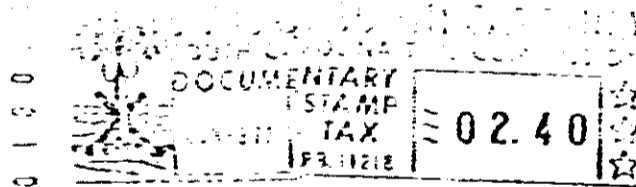

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the city of Mauldin, being known and designated as Lot No. 38, as shown on plat of BROOKSIDE, SECTION TWO, recorded in plat book 5 D page 24 of the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Stoneybrook Trail, the joint front corner of Lots 37 & 38, and running thence with the joint line of said lots S. 4-00 E. 165 feet to an iron pin in rear line of lot 30; thence with the line of lot 30, S. 88-33 W. 112.6 feet to an iron pin joint rear corner of Lots 38 & 39; thence with the joint line of said lots N. 4-00 W. 160 feet to an iron pin on the south side of Stoneybrook Trail; thence with the south side of said street N. 85-00 E. 112.5 feet to the point of beginning.
