

EDDIE S. STANERLEY  
MORTGAGE

THIS MORTGAGE is made this 6th day of June, 1977, between the Mortgagor, EARL DEAN HANLEY and DEBORAH J. HANLEY (herein "Borrower"), and the Mortgagee, GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 107 Church Street, Greer, South Carolina 29651 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Thirty-two Thousand and 00/100 (\$32,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated June 6, 1977 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on June 1, 2007;

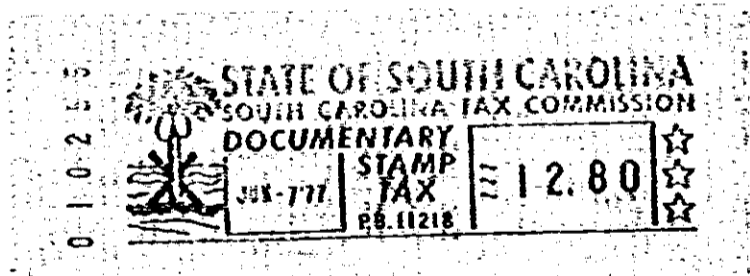
To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township, shown as LOT NO. 1 on plat of Boyd C. Lister and Sybil L. Lister prepared by Terry T. Dill, R.L.S., dated August 15, 1970 and recorded in the R.M.C. Office for Greenville County in Plat Book 4-H at Page 115, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Oneal-Church Street at the corner of Lot No. 15 and running thence along said lot N. 10° 45' W. 137 feet to an iron pin; thence N. 78° 46' E. 200.8 feet to an iron pin; thence along S.C. Highway No. 101 N. 10° 45' W. 116.4 feet to an iron pin; thence N. 35° 21' E. 35.2 feet to an iron pin; thence along Oneal-Church Street N. 80° 12' E. 174.4 feet to the point of beginning.

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
