entry of a judgment enforcing this Mongage if: (a) Borower pays Londer all sums which would be then due under this Mongage. the Note and notes securing Future Advances, if any, had no acceleration occurred; (b) Birriwer cures all breaches of any other covenants or agreements of Borrower contained in this Matgage; (c) Borrower pays all reasonable expenses incurred by Lender in enfercing the evenints and agreements of Borrower contained in this Mortgage and in enfercing Lender's remedies as provided in paragraph 18 bereof, including, but not limited to, reasonable attorney's fees; and (d) Barrower takes such action as Lender may reasonably require to assure that the lien of this Mortgage, London's interest in the Property and Borrower's obligation to pay the sums secured by this Mortgage shall continue unimpaired. Upon such payment and cure by Borrower, this Mortgage and the obligations secured hereby shall remain in full force and effect as if no acceleration had occurred.

20. Assignment of Rents; Appointment of Receiver. As additional security bereunder, Borrower bereby assigns to Lender the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 18 hereof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable.
