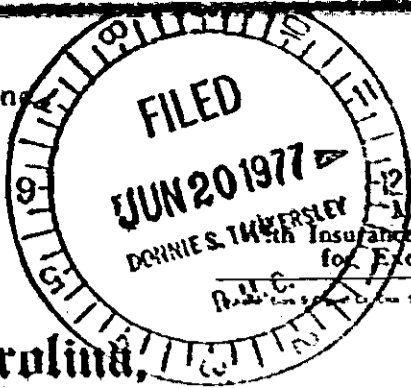

with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and
truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowl-
edged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said
Domestic Loans of Greenville, Inc. their successors.

All that certain piece, parcel or lot of land on the western side of Old Augusta Road,
being shown and designated as Lot No. 5 on plat of property of Marie Dreher, recorded
in Plat Book CCC, at page 119 in the R.M.C. Office for Greenville County, said property
being in the County of Greenville, State of South Carolina, and having, according to said
plat, the following metes and bounds, to-wit:

Beginning at a point on the western side of Old Augusta Road at the joint front corner of
Lots Nos. 5 and 6, and running thence with the joint line of said lots, S. 67-00 W. 149.9
feet to a point; thence running S. 14-00 E. 61.5 feet to a point at the joint rear corner
of Lots Nos. 4 and 5; thence running with the joint line of said lots, N. 76-15 E. 149.6
feet to a point on the western side of Old Augusta Road; thence with Old Augusta Road,
N. 15-30 W. 74.3 feet to the point of beginning, being the same property conveyed to the
