THIS CONVEYANCE IS MADE UPON THIS SPECIAL TRUST, that If the Hortgagors shall pay the Promissory Note secured hereby, in accordance with its terms, and any renevals and extensions thereof in whole or in part, and shall comply with all the covenants, terms and conditions of this Mortgage, then this conveyance shall be null and void and may be cancelled of record at the request of Mortgagors.
