TO ALL WHOM THESE PRESENTS MAY CONCERN:

W. Lynell Sumner and Evelyn M. Sumner

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirty-one Thousand Five Hundred and no/100-----

DOLLARS (\$31,500.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

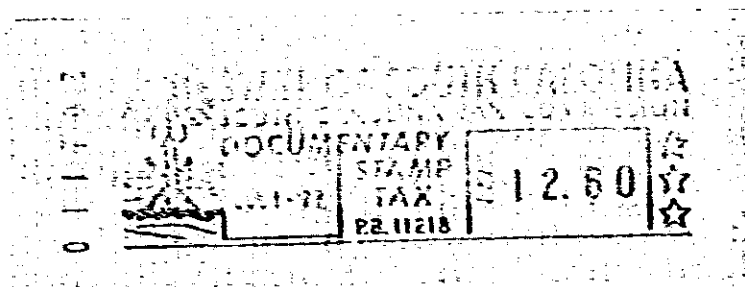
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being

ALL that piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina being known and designated as Lot No. 217 on a plat of Westcliffe, Section 3-B recorded in Plat Book JJJ at Pages 72 through 75 in the R.M.C. Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Eastcliffe Way at the joint front corner of lots nos. 217 and 218 and running thence with the common line of said lots N. 28-14 W. 139.6 feet to an iron pin; running thence N. 57-20 E. 100 feet to an iron pin at the corner of lots 216 and 217; running thence with the common line of said lots S. 36-38 E. 165.6 feet to an iron pin on the northern side of Eastcliffe Way; running thence with the northern side of said Way S. 68-17 W. 65 feet to a point; thence continuing with the northern side of Eastcliffe Way S. 70-32 W. 60 feet to the point of beginning.
