TO ALL WHOM THESE PRESENTS MAY CONCERN:

ROSAMOND ENTERPRISES, INC. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Fifty-Nine Thousand Two Hundred and No/100 ----- DOLLARS

(\$ 59,200.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 11 on a plat of Holly Hill Subdivision dated February 17, 1977 amended April 5, 1977, prepared by C. O. Riddle, Surveyor recorded in Plat Book 5-P at Page 85 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Holly Hill Lane at the joint front corner of Lot 10 and Lot 11 and running thence with Lot 10, N. 5-30 W. 161.8 feet to an iron pin at the joint rear corner of Lot 10 and Lot 11; thence with Lot 16 and Lot 15, N. 87-57 W. 116.1 feet to an iron pin at the joint rear corner of Lots 11, 13, 14 and 15; thence with Lot 13, S. 2-16 W. 72-8 feet to an iron pin at the joint rear corner of Lots 11, 12 and 13; thence with Lot 12, S. 23-42 E 125 feet to an iron pin on the northern side of Holly Hill Lane; thence with said Lane, N. 75-24 E 87 feet to the point of beginning.
