the Note and notes scenting future Advances, if any, had to reache not occurred. In Parawar cures all freaches of any other extensits or agreements of Borrover contained in this Mortgage, or Borrover pays all reasonable expenses in usual by Teacher in enforcing the evenants and agreements of Borrover contained in this Mortgage and in enforcing Teacher's remedies as practical in paragraph 18 hereof, including, but not limited to, reasonable attorney's feest and (d). - 22. Release. Upon payment of all sums secured by this Mertgage, this Mortgage shall become null and void, and Lender shall release this Mortgage without charge to Borrower. Borrower shall pay all costs of recordation, if any.
 - 23. Waiver of Homestead. Borrower hereby waives all right of homestead exemption in the Property.
