MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: CHARLES CRAIG ZENDE AND NANCY ELLEN ZENDE

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Eight Thousand Two Hundred and No/100----- DOLLARS

(\$ 38,200.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty (30) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Del Norte Road and being known and designated as Lot No. 77 on plat of Del Norte Estates recorded in the R.M.C. Office for Greenville County in Plat Book WWW, Pages 32 and 33 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Del Norte Road at the joint front corner of Lots 76 and 77 and running thence S. 42-23 E., 140 feet to an iron pin; thence along the rear of Lot 77 S. 46-48 W., 110 feet to an iron pin at the rear of Lot 77; thence running N. 39-39 W., 140 feet to an iron pin on the southern side of Del Norte Road; thence running along Del Norte Road N. 46-33 E., 103.4 feet to the point of beginning.

This is the same property conveyed to the mortgagors by deed of Ronald S. Lee and Joan K. Lee recorded in the R.M.C. Office for Greenville County on July 28, 1977, in Deed Book 1161, Page 377.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagors promise to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagors fail to pay it.
