PARCEL 2:

All that piece, parcel or lot of land lying and being situate on the Northerly side of Carver Road, Chick Springs Township, Greenville County, South Carolina, being known and designated as Lot No. 11 according to a plat of Property of Lily McC Loftis, prepared by Terry T. Dill, dated February 23, 1961, as recorded in Plat Book "GGG" at pages 456 and 457, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northerly side of Carver Road at joint front corner of Lots 11 and 12 and running thence along the joint line of said lots N. 29-18 E. 201 feet to an iron pin; thence along the rear line of Lots 3 and 4 S. 34-00 E. 180 feet to an iron pin at joint rear corner of Lots 4, 5, 10 and 11; thence along the joint line of Lots 10 and 11 S. 56-00 W. 167 feet to an iron pin at joint front corner of said lots on the Northeast side of Carver Road; thence along said Carver Road N. 34-00 W. 20.5 feet to an iron pin; thence further along Carver Road on an angle, the chord of which is N. 45-23 W. 60.3 feet to an iron pin at the point of beginning.

All that piece, parcel or lot of land situate, lying and being on the Southwestern side of Lincoln Road, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 5 as shown on a plat prepared by Terry T. Dill, dated October 3, 1959, revised September 27, 1960, entitled "Section Two, Plat of Property of Lily McC Loftis", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "VV" at page 29 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Lincoln Road at the joint front corner of Lots Nos. 4 and 5 and running thence with the line of Lot No. 4 S. 55-57 W. 149.8 feet to an iron pin; thence S. 34-03 E. 90 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6; thence with the line of Lot No. 6 N. 55-57 E. 149.9 feet to an iron pin on the Southwestern side of Lincoln Road; thence with the Southwestern side of Lincoln Road N. 34-03 W. 90 feet to the point of beginning.

This is the identical property conveyed to the Mortgagors, Willie Anderson and Emma Lou Anderson, by deed of Lily McC. Loftis, dated January 14, 1965, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 768 at page 455 on March 4, 1965.
