We, Henry B. Godfrey and Bobbie M. Godfrey
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **thirty-five thousand and no/100-----** DOLLARS

(\$ **35,000.00**), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **25** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being shown and designated as Lot No. 116 as shown on plat of Coach Hills recorded in the R. M. C. Office for Greenville County in Plat Book 4X at page 86, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on Coach Hills Drive at the joint front corner of Lots Nos. 116 and 117, and running thence with the joint line of said lots, S. 50-19 W. 152.20 feet to iron pin; thence N. 50-17 W. 130 feet to iron pin at the joint rear corner of Lots Nos. 115 and 116; thence with the joint line of said lots, N. 63-54 E. 219.78 feet to iron pin on Coach Hills Drive; thence with Coach Hills Drive, S. 17-05 E. 33 feet to point; thence continuing with Coach Hills Drive, S. 11-03 E. 51.91 feet to the beginning corner.
