MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, W. H. Alford

(hereinafter referred to as Mortgagor) is well and truly indebted unto C. E. Robinson, Jr., as Trustee under the Trust Estate of B.M. McGee under deed.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Thousand Five Hundred and No/100-----
-----Dollars (\$ 5,500.00) due and payable

on or before six (6) months from date

with interest thereon from date at the rate of eight per centum per annum, to be paid: at maturity.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, being known and designated as Tract 3 of the Berry Garrett Estate according to a survey and plat of same made by W. J. Riddle, Surveyor, dated April 24, 1928, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the line of W. J. Wood land and running thence along this line, N.47-30 E. 504 feet to B. O.; thence continuing along line of Wood land, N.03-30 E. 421 feet to B. O.; thence along line of land of St. S. Wood, S.47-20 W. 792 feet to a W. O.; thence S.39-13 E. 292 feet to an iron pin at the beginning corner and containing approximately 4.3 acres, more or less.

This is the same property as that conveyed to the Mortgagor herein by deed from Sunnie Garrett, now Sunnie Garrett Smith, recorded in the RMC Office for Greenville County in Deed Book 852 at Page 649 on September 24, 1968.
