WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Thousand and no/100-----DOLLARS

(\$30,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty (30) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Bradley Boulevard in the City of Greenville, being shown and designated as Lot No. 87 on plat of University Park, prepared by Dalton & Neves, Engineers, dated November 1946, recorded in Plat Book P at Page 127 and being described, according to said plat, more particularly, to-wit:

BEGINNING at an iron pin on the northwestern side of Bradley Boulevard at the joint front corner of Lots 86 and 87 and running thence along said boulevard S. 52-26 W. 75 feet to an iron pin at the joint front corner of Lots 87 and 88; thence along the common line of said lots N. 37-34 W. 254.1 feet to an iron pin at the joint corner of Lots 87 and 126 on the southern side of Brookside Circle; thence along said circle N. 77-34 E. 82.85 feet to an iron pin at the joint rear corner of Lots 86 and 87; thence along the common line of said lots S. 37-34 E. 218.6 feet to an iron pin on the northwestern side of Bradley Boulevard, the point of beginning.
