TO ALL WHOM THESE PRESENTS MAY CONCERN:

with interest thereon from date hereof at the rate of 7 per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot No. 30 as shown on a plat entitled "Property of Leslie & Shaw, Inc." prepared by C.C. Jones & Associates, dated February, 1957, and recorded in the R.M.C. Office for Greenville County in Plat Book NN, Page 3 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Mora Street in the joint front corner of Lots Nos. 29 and 30, and running thence with the line of Lot No. 29, N. 76-05 W., 77.4-feet to an iron pin at the joint corner of Lots Nos. 29, 30 and 31; thence with the line of Lot No. 31, S. 52-09 W., 77.6-feet to an iron pin on the Northeastern side of Nuggat Street; thence with the Northeastern side of Nuggat Street S. 37-51 E., 141.4-feet to an iron pin; thence with the curve of the intersection of Nuggat Street and Mora Street, the chord of which is N. 77-34 E., 17.5-feet to an iron pin on the Northwestern side of Mora Street; thence with the Northwestern side of Mora Street N. 13-55 E. 141.4-feet to the point of beginning.
