### MORTGAGE

STATE OF SOUTH CAROLINA  
COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN: L. JERRY CHAPMAN and

MARY FRANCES CHAPMAN (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twelve Thousand and No/100

DOLLARS (\$ 12, 000. 00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

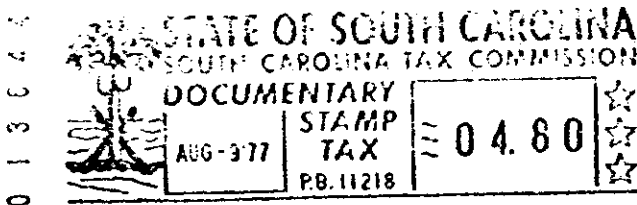
WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the city of Greenville, state of South Carolina, known and designated as Lot No. 7, Essex Court, according to a plat recorded in Greenville County RMC Office in plat book W page 31, and having according to said plat the following metes and bounds, to wit:

Beginning at a stake on the west side of Essex Court, 363 feet north from County (Gilfillin Road), the joint front corner of Lots 6 and 7; thence with the line of lot 6, S. 86-15 W. 119.4 feet to a stake; thence N. 1-50 W. 64.04 feet to a stake at rear corner of Lot 8; thence with line of lot 8, N. 86-15 E. 117.2 feet to a stake on Essex Court; thence with the western side of Essex Court, S. 3-45 E. 64 feet to the beginning corner.
