entry of a judgment enforcing this Mangage if: (a) Barrower pays Londer all sums which would be then due under this Mangage, the Note and notes securing Future Advances, if any, had no acceleration occurred; (b) But wer cures all breaches of any other owenints of agreements of Bottower contained in this Mortgage; (c) B trower pays all reasonable expenses incurred by Lender in enfercing the ovenants and agreements of Botrower contained in this Mortgage and in enforcing Lender's remedies as provided in paragraph 18 hereof, including, but not limited to, reasonable attorney's fees; and (d) Borrower takes such action as Lender may reasonably require to assure that the lien of this Mottgage, Londor's interest in the Property and Borrower's obligation to pay the sums secured by this Mortgage shall continue unimpaired.
