WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 86, Section II, of Subdivision known as Poinsettia, said Subdivision being situated within the corporate limits of the Town of Simpsonville, plat of said Subdivision being recorded in the RMC Office for Greenville County in Plat Book BBB, at Page 199, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point on the southeastern side of Fernwood Road at the joint front corner of Lots 86 and 87 and running thence along the common line of said Lots S. 42-12 E. 125.01 feet to a point; thence S. 49-57 W. 206.9 feet to a point; thence N. 46-43 W. 60.0 feet to a point; thence N. 32-28 W. 90.0 feet to a point; thence following the curve of the intersection of an unnamed street and Fernwood Road N. 15-47 E. 33.3 feet to a point on the southeastern side of Fernwood Road; thence along the said Fernwood Road N. 64-02 E. 175.0 feet to the point of beginning.
