

# MORTGAGE

THIS MORTGAGE is made this 22nd day of August, 1977, between the Mortgagor, Charles I. Davis and Shirley A. Davis (herein "Borrower"), and the Mortgagee, GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 107 Church Street, Greer, South Carolina 29651 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty-six Thousand Five Hundred and no/100----- Dollars, which indebtedness is evidenced by Borrower's note dated August 22, 1977 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on August 1, 1997;

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

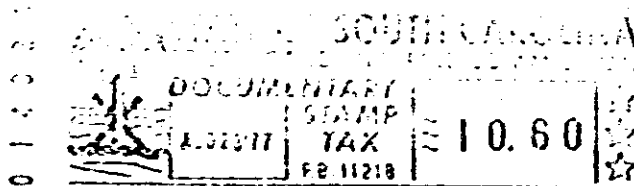
ALL that piece, parcel or lot of land with all buildings and improvements situate, lying and being on the easternly side of Maria Louisa Lane in Greenville County, South Carolina, being known and designated as Lot No. 1 on a plat entitled "Property of C. B. Jones" made by H. C. Clarkson, Jr. dated September 22, 1969, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Maria Louisa Lane at the joint front corner of lots nos. 1 and 2 and running thence with Maria Louisa Lane N. 14-24 E. 151.6 feet to an iron pin; thence S. 72-48 E. 95.2 feet to an iron pin; thence S. 57-31 E. 100 feet to an iron pin; thence S. 23-06 W. 117.3 feet to an iron pin; thence N. 75-36 W. 172.4 feet to an iron pin on the eastern side of Maria Louisa Lane, the point of beginning.

This is the same property conveyed to Charles I. Davis and Shirley A. Davis by deed of Jack A. Watson, Jr. and Joy B. Watson dated August 22, 1977 to be recorded herewith.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
