"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known as Unit 21-C in BRIARCREEK CONDOMINIUMS, Horizontal Property Regime, situate on or near the southerly side of Pelham Road in the City of Greenville, as more particularly described in Master's Deed and Declaration of Condominium, dated September 20, 1972, and recorded in the R.M.C.
