WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-Three Thousand and No/100 DOLLARS

(\$43,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-nine (29) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

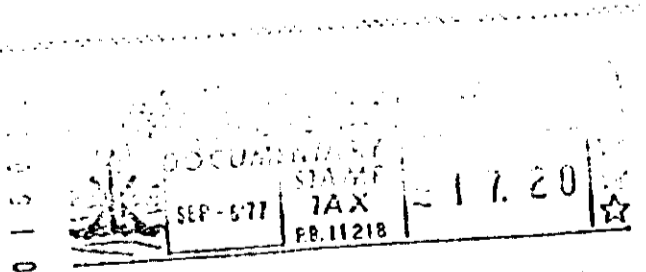
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeasterly side of Pine Wood Drive, being shown and designated as Lot No. 126 on plat of Pine Brook Forest Subdivision, recorded in the RMC Office for Greenville County, S. C., in Plat Book "4 X", at Pages 48 and 49, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeasterly side of Pine Wood Drive, joint front corner of Lots Nos. 127 and 126, and running thence with the southeasterly side of Pine Wood Drive, N. 29-17 E. 123.5 feet to an iron pin at the joint front corner of Lots Nos. 125 and 126; thence with the joint line of said lots, S. 83-33 E. 135 feet to an iron pin at the rear corner of Lot No. 125; running thence S. 21-51 W. 188.5 feet to an iron pin at the joint rear corner of Lots Nos. 126 and 127; thence with the joint lines of said lots, N. 56-37 W. 150 feet to the point of BEGINNING.
