TO ALL WHOM THESE PRESENTS MAY CONCERN:

Robert F. Solley

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-two Thousand Five Hundred and no/100----- DOLLARS

(\$ 22,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Riverwood Court, being known and designated as Lot No. 142 on a plat of Berea Forest, Section No. II, Sheet No. 1, made by Piedmont Engineers and Architects, dated April 14, 1972, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4-N at Page 76 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Riverwood Court at the joint corner of lots nos. 142 and 143 and running thence with the common line of said lots N. 49-33 W. 153.1 feet to an iron pin; thence S. 60-55 W. 120.0 feet to an iron pin; thence S. 29-05 E. 120.0 feet to an iron pin at the joint rear corner of lots nos. 141 and 142; thence along the common line of said lots N. 81-06 E. 153.2 feet to an iron pin on the western side of Riverwood Court; thence along the curve of the western side of Riverwood Court the chord of which is N. 15-20 E. 41.75 feet to an iron pin, the point of beginning.

The above property is the same property conveyed to Robert F. Solley by deed of Frank P. McGowan, Jr. as Master in Equity to be recorded herewith.
