TO ALL WHOM THESE PRESENTS MAY CONCERN: Allen S. Hearn and Patricia A. Hearn

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-Eight Thousand Four Hundred and NO/100ths . . . . . DOLLARS

(\$ 38,400.00 . . . ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is Thirty (30) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 34 of a subdivision known as Canebrake I as shown on plat thereof prepared by Enwright Associates dated August 18, 1975, and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 5-D at Pages 95 and 96 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Saratoga Drive, the joint front corner of Lots 33 and 34 and running thence with the joint line of said lots, N. 36-00 E. 151.90 feet to a point at the high water contour of lake being the property line; thence with said line, the chord of which is S. 63-14 E. 78.55 feet to a point; thence continuing S. 37-34 E. 8.88 feet to a point at the joint rear corner of Lots 34 and 35; thence with the joint line of said Lots, S. 36-00 E. 161.89 feet to an iron pin on the northeastern side of Saratoga Drive; thence with said Drive, N. 54-00 W. 86 feet to the point of beginning.

This conveyance is made subject to any restrictions, easements, or right-of-way, if any, affecting the above property.
