

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot 17, Hudson Acres, plat of which is recorded in the RMC Office for Greenville County, in Plat Book Y, at Page 39, and having, according to said plat the following metes and bounds:

BEGINNING at an iron pin on the northerly side of Butler Springs Road joint front corner of Lots 17 and 19, and running thence N. 25 E. 257.5 feet to an iron pin; thence N. 69-15 W. 185.6 feet to an iron pin; thence S. 23-30 W. 198.8 feet to an iron pin on Butler Springs Road, joint front corner of Lots 15 and 17; thence along Butler Springs Road, S. 45-15 E. 100 feet to a point and continuing along Butler Springs Road S. 57-30 E. 85.3 feet to an iron pin, the point of beginning.
