

| Ninety three and 85/100 (\$ 293.85) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date; and |

due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 13, Governor's Square, prepared by W.R. Williams, Jr., dated October 17, 1975, recorded in the RMC Office for Greenville County, S. C., in Plat Book 5-P at Page 8, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin, eastern side of Governor's Square, joint front corner of Lot 13 and 14, running thence with joint line of said lots N60-10E, 190 feet to an iron pin, joint rear of Lots 13 & 14, thence running with the joint rear of Lot 13, S10-13W. 142.7 feet to an iron pin; thence running with the southern side of Lot 13, S. 70-41W. 115.1 feet to an iron pin on the eastern side of Governor's Square, thence running with Governor's Square the following: N9-22E 54.7 feet; thence N5302 W. 49.9 feet to an iron pin, the point and place of beginning.
