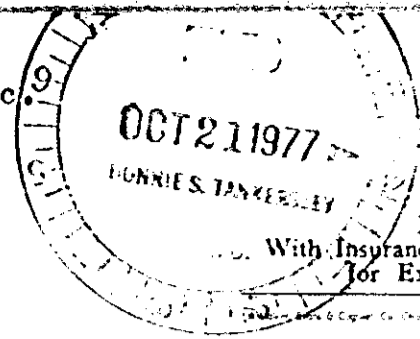

NOW, KNOW ALL MEN, that we the said Theodore Campbell and Dorothy Campbell in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Domestic Loans of Greenville, Inc.

All that certain parcel or lot of land situated on the southwest side of State Highway No. 290 (formerly No. 415) about five miles northwestward from the City of Greer, Oneal Township, Greenville County, State of South Carolina, and being Lot No. 18, Section 1, as shown on a plat of subdivision known as Paris View, made by J. D. Calmes, April, 1961, recorded in the RMC Office for Greenville County, in Plat Book "VV", page 101, and having the following courses and distances:

Beginning on an iron pin on the margin of State Highway No. 290, joint corner of Lots No. 17 and 18, and runs thence S. 38-23 W. 200 feet to an iron pin; thence S. 51-37 E. 100 feet to an iron pin; thence N. 38-25 E. 200 feet to an iron pin on said highway; thence therewith, N. 51-37 W. 100 feet to the beginning.

ALSO: All that piece, parcel or lot of land in Oneal Township, Greenville County, State of South Carolina, being known and designated as Lot no. 17 of Paris View, Section #1, as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book "VV", page 101, and being described according to said plat as follows:

Beginning at an iron pin on the southwestern side of S.C. Highway No. 415 at the joint front corner of Lots No. 17 and 18, and running thence along the line of Lot No. 18, S. 38-23 W. 200 feet to an iron pin at the joint rear corner of Lots Nos. 17, 18, 30 and 31; thence along the line of Lot No. 31, N. 51-37 W. 110 feet to an iron pin at the joint rear corner of Lots No. 16 and 17; thence along the line of Lot No. 16, N. 38-23 E. 200 feet to an iron pin on the southwestern side of S.C. Highway No. 415; thence along S.C. Highway No. 415 S. 51-37 E. 110 feet to the beginning corner.
