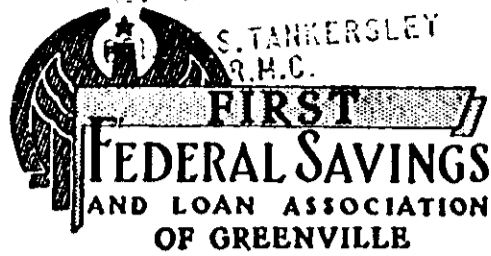

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

That Willie E. Parker and Sandra M. Parker

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

- Thirty thousand four hundred - - - - - (\$ 30,400.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

Two hundred forty-four and 61/100 - - (\$ 244.61) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Mauldin, on the northern side of Bishop Drive, being shown and designated as Lot 34 on a Plat of BISHOP HEIGHTS Subdivision, recording in the RMC Office for Greenville County in Plat Book BBB, at Page 171, and having, according to said Plat, the following metes and bounds:

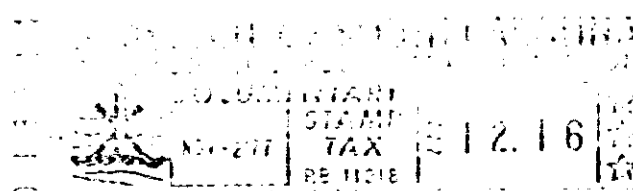
BEGINNING at an iron pin on the northern side of Bishop Drive, at the joint front corner of Lot 34 and Property of B. M. Snow and running thence with the joint line of said Lots, and property of W. D. Bishop, N 06-00 W, 317.3 feet to an iron pin at the joint rear corner of Lot 34 and Property of W. D. Bishop; thence along the rear line of Lot 34, S 84-00 W, 50 feet to the joint rear corner of Lots 33 and 34; thence along the common line of said Lots, S 07-53 W, 287.18 feet to an iron pin on the northern side of Bishop Drive; thence with the side of said Drive, S 78-03 E, 125 to an iron pin, the point of beginning.

- ALSO -

ALL that certain lot of land lying on the northern side of Bishop Drive, East of and adjacent to Lot 34, BISHOP HEIGHTS Subdivision, in the Town of Mauldin, Greenville County, South Carolina, and having the following metes and bounds:

BEGINNING at an iron pin on the northern side of Bishop Drive, at the joint front corner of Lot 34, BISHOP HEIGHTS Subdivision, and running thence with the joint line of said Lot, N 6 W, 108 feet to an iron pin on the line of Property of W. D. Bishop; thence along the Bishop line, N 83-28 E, 50 feet, more or less, to a point on the fence; thence with the fence as the line, in a southerly direction, 120 feet, more or less, to a point on the northern edge of Bishop Drive; thence with the side of Bishop Drive, N 78-30 W, 25 feet to an iron pin, the point of beginning.

This is the same property conveyed to the Mortgagors herein by deed of Helmut H. Lurtz, dated October 20, 1977, to be recorded simultaneously herewith.
