Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville

ALL that piece, parcel or lot of land, with all improvements, thereon, situate, lying and being in Greenville County, South Carolina being known and designated as Lot 108 as shown on plat of "South Forest Estates" as recorded in the RMC Office for Greenville County, South Carolina in Plat Book GG, Page 181, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on Stratford Road, joint front corner of Lots 108 and 109, thence S. 84-41 W. 125 feet to an iron pin, joint rear corner of Lots 108, 109, 132, 133; thence N. 5-20 W. 85 feet to an iron pin, joint rear corner of Lots 107, 108, 133, 134; thence N. 84-41 E. 125 feet to an iron pin on Stratford Road; thence S. 5-20 E. 85 feet along Stratford Road to the point of beginning.
