I, Luther Winford Stringer

SEND GREETING:

WHEREAS, I the said Luther Winford Stringer

in and by my certain promissory note in writing of even date with these Presents, am well
and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of
Nine Thousand and no/100 - - - (\$ 9,000.00) Dollars,
with interest from the date hereof at the rate of **nine** per cent (**9%**) per annum, unpaid interest to
bear interest at the same rate, to be repaid in installments of **One Hundred Fourteen and 01/100**

- - - - - (\$ 114.01) Dollars
due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest

Dollars to me the said mortgagor in hand well and truly paid by the said mortgagee, at and
before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained,
sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND

constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland
Township, located on both sides of Stringer Road and on the east and south sides of
Beaverdam Creek and being shown on plat of property made for L. W. Stringer by W. N.
Willis, Surveyor, dated 3-23-72, filed by S. D. Atkins and having the following metes

W., 525 feet, S. 1-30 W., 50 feet, thence S. 70-00 W., 211 feet (crossing back over
said road), thence S. 60-05 W., 279 feet, thence S. 53-58 W., 334 feet, thence about
