"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Theodore Circle, and shown and designated as Lot No. 7 on plat entitled "Section No. 2, Carolina Heights", prepared by Dalton & Neves, Engineers, dated October, 1965, and recorded in the RMC Office for Greenville County in Plat Book BBB at Page 161, and having, according to said plat, the following metes and bounds, to-wit:
