

All that certain parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, about one and one-half miles North of Tigerville Community, on the North side of State Highway No. 11, being shown as containing 5.30 acres on a plat of property prepared for Darrell K. Harrison by Tri-State Surveyors, dated May 7, 1974, recorded in Plat Book 5-B page 104, and having such metes and bounds as is thereby shown. According to said plat, said property fronts 722.5 feet on the North side of State Highway No. 11, with a depth of 192 feet on the West, a depth of 559.7 feet on the East, and with a rear width along meanders of a branch of 622.8 feet.
