"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as 6.2 acres, more or less, on a plat of property of John Henry Thomason, which plat is of record in the RMC Office for Greenville County in Plat Book 4K-189, reference to which is hereby craved for a metes and bounds description thereof.
