

THIS MORTGAGE made this 8th day of November, 19 77,
among W. Randy Goodwin and Nancy L. Goodwin (hereinafter referred to as Mortgagor) and FIRST
UNION MORTGAGE CORPORATION, a North Carolina Corporation (hereinafter referred to as Mortgagee):

WITNESSETH THAT, WHEREAS, Mortgagor is indebted to Mortgagee for money loaned for which
Mortgagor has executed and delivered to Mortgagee a Note of even date herewith in the principal sum of
Five Thousand, Five Hundred and No/100----- (\$ 5,500.00), the final payment of which
is due on November 15 19 82, together with interest thereon as
provided in said Note, the complete provisions whereof are incorporated herein by reference;

AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest
thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the
Note and this Mortgage by the conveyance of the premises hereinafter described:

NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in
hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys,
assigns and releases to Mortgagee, its successors and assigns, the following described premises located in
Greenville County, South Carolina:

ALL that certain tract of land situate in Fairview Township, County of Green-
ville, State of South Carolina, near the Town of Fountain Inn, containing
.5 acres in accordance with plat made by J. D. Calmes, dated April, 1962, and
being more fully described in accordance with said plat, to-wit:

BEGINNING at an iron pin at the intersection of old S.C. Highway 418 and Jenkins
Bridge Road, and runnin thence along said old S.C. Highway 418, S. 7-08 E. 155
feet to an iron pin; thence S. 80-57 W. 150 feet to an iron pin; thence N. 9-03 W.
130 feet to an iron pin; thence N. 71-30 E. 157.4 feet to an iron pin at the
point of beginning.

The above conveyance excludes that portion of the property along Jenkins Bridge
Road and triangular portion of property along S.C. Highway 418 as condemned and
taken by S.C. Highway Department.

THIS being the same property conveyed to the mortgagors herein by deed of Ronald
T. Corn and Angela D. Corn, dated April 30, 1969 and recorded in the RMC Office
for Greenville, S.C. on May 2, 1969 in Deed Book 867 at Page 238.

THIS mortgage is second and junior in lien to that mortgage in favor of Cameron-
Brown Company in the amount of \$14,650.00, recorded in the RMC Office for
Greenville County, S.C. in Mortgage Book 1068 at Page 651 on Sept. 11, 1967.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises
belonging or in anywise incident or appertaining. Including but not limited to all buildings, improvements,
fixtures, or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures, or
articles, whether in single units or centrally controlled, used to supply heat, gas, air conditioning, water, light,
power, refrigeration, ventilation or other services, and also together with any screens, window shades, storm
doors and windows, screen doors, awnings, stoves and water heaters (all of which are declared to be a part of
said real estate whether physically attached thereto or not).

TO HAVE AND TO HOLD the same with all privileges and appurtenances thereunto belonging to Mortgagee,
its successors and assigns, forever, for the purposes hereinafter set out and Mortgagor covenants with Mortgagee,
its successors and assigns, that Mortgagor is seized of, and has the right to convey, the premises in fee simple;
that the premises are free and clear of all encumbrances except for a prior Mortgage, if any; and that Mortgagor
will warrant and defend title to the premises against the lawful claims of all persons whomsoever.

MORTGAGOR COVENANTS with Mortgagee, its heirs, successors and assigns as follows:

1. NOTE PAYMENTS. Mortgagor shall make timely payments of principal and interest on the above
mentioned Note in the amounts, in the manner and at the place set forth therein. This Mortgage secures payment
of said Note according to its terms, which are incorporated herein by reference.
2. TAXES. Mortgagor shall pay all taxes, charges and assessments which may become a lien upon the
premises hereby conveyed before any penalty or interest accrues thereon and shall promptly deliver to
Mortgagee (at its request) official receipts evidencing payment thereof. In the event of the passage after the date
of this Mortgage of any law imposing a federal, state or local tax upon Mortgage or debts secured thereby, the
whole principal sum (together with interest) secured by this Mortgage shall, at the option of Mortgagee, its
successors and assigns, without notice become immediately due and payable.
