All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 31 on a plat of Pelham Estates, dated July 1966, recorded in the RMC Office for Greenville County, in the RMC Office for Greenville County in Plat Book PPP at page 28 and 29, and having according to said plat the following metes and bounds to-wit:
