20. Assignment of Rents: Appointment of Receiver. As additional security hereunder, Bostower hereby assigns to Lender the rents of the Property, provided that Bostower shall, prior to acceleration under paragraph 18 hereof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable.

23. Waiver of Homestead. Borrower hereby waives all right of homestead exemption in the Property.
