The Mortgagor represents and warrants that said Mortgagor is sound of the above described premises in feels right about that the above described premises are free and clear of all hers or other encountraines, that the Mortgagor is lawfully engaged to convey or encounter the same, and that the Mortgagor will forever defend the said premises unto the Mortgagor its sources ors and assigns, from and against the Mortgagor and every person whomsoever lawfully claiming or to claim the synce or any part the right.

## THE MORIGAGOR COVENANTS AND AGREES AS FOLLOWS:

- 1. That the Mortgagor will promptly pay the principal and interest on the indebtedness evidenced by said promisory note at the times and in the manner therein provided.
- 2. That this mortgage will seeme the Mortgagee for any additional sums which may be advanced bereafter, at the option of the Mortgagee, for the payment of taxes, or public assessments, hazard insurance premiums, repairs or other soch purposes pursuant to the provisions of this mortgage, and also for any loans or advances that may bereafter be made by the Mortgagee to the Mortgagor under the authority of Sec. 45-55, 1962 Code of laws of South Carolina, as amended, or similar statutes, and all sums so advanced shall bear interest at the same rate or rates as that provided in said note unless otherwise agreed upon by the parties and shall be payable at the demand of the Mortgagee, unless otherwise provided in writing.
- 3. That Mortgagor will keep the improvements on the mortgaged premises, whether now existing or hereafter to be erected, insured against loss by fire, windstorm and other hazards in a sum not less than the balance due bereinder at any time and in a company or companies acceptable to the Mortgagee, and Mortgagor does hereby assign the policy or policies of insurance to the Mortgagor and agrees that all such policies shall be held by the Mortgagor should it so require and shall include his payable classes in favor of the Mortgagor, and in the event of loss, Mortgagor will give immediate notice thereof to the Mortgagor by registered read and shall the Mortgagor at any time fail to keep said premises insured or fail to pay the premiums for such insurance, then the Mortgagor may cause such improvements to be insured in the name of the Mortgagor and rembuse itself for the cost of such insurance, with interest as hereinabove provided.
- 4. That the Mortgagor will keep all improvements upon the mortgaged premises in good repair, and should Mortgagor fail to do so, the Mortgagor may, at its option, enter upon said premises and make whatever repairs are necessary and charge the expenses for such repairs to the mortgage delst and collect the same under this mortgage, with interest as bereinshore provided.
- 5. That the Morteagee may at any time require the issuance and maintenance of insurance upon the life of any preson obligated under the indefeedness secured hereby in a sum sufficient to pay the mortgage deld with the Mortgagee as beneficiary, and if the premiums are not otherwise paid, the Mortgagee may pay said premiums and any amount so paid shall become a part of the mortgage delt.
- 6. That Mortgagor agrees to pay all taxes and other public assessments levied against the mortgaged premises on or before the due dates thered and to exhibit the receipts therefor at the offices of the Mortgager immediately upon payment, and should the Mortgagor fail to pay such taxes and assessments when the same shall fall due, the Mortgager may, at its option pay the same and charge the amounts so paid to the mortgage debt and collect the same under this mortgage, with interest as above provided.
- 7. That if this mentgage secures a "construction loan", the Montgagos agrees that the provipul amount of the sudelifiedness hereby secured shall be disturbed to the Montgagos in periodic parametric, as construction processes, in accordance with the terms and conditions of a Construction Loan Agreement which is separately excepted but is made a part of this mentgage and incorporated herein by reference.
- S. That the Meetensee will not further examiner the premises along described, without the pine consent of the Meetensee, and should the Meetensee so examiner such premises the Meetensee may, at its option declare the indebediess hereby secured to be immediately due and payable and may matrice any proceedings necessary to collect said indebediess.
- 9. That should the Mietzagor alienate the mietzaged premises by Contract of Sale Bond for Tale, or Deed of Conveyance, and the within mortgage indefenders is not paid in full, the Mintgagor or his Princhiser shall be required to file with the Association an application for an assumption of the mintgage indefenders, pay the reasonable cost as required by the Association for processing the assumption, furnish the Association with a copy of the Contract of Sale, Bond for Tale, or Deed of Conveyance, and have the interest rate on the loss fulance existing at the time of transfer modified by increasing the interest rate on the said four balance to the maximum rate per annum permitted to be charged at that time by applicable South Carolina law, or a lesser increase in interest rate as may be determined by the Association. The Association will notify the Mortgagor or his purchaser of the new interest rate and monthly payments and will mail him a new pushook. Should the Mortgagor, or his Purchaser, fail to comply with the provisions of the within puragraph, the Mortgagor, at its option, may declare the indefeedness hereby second to be immediately due and payable and may institute any proceedings successary to collect said indefeedness.
- 10. That should the Mortgagor fail to make payments of principal and interest as due on the promissors note and the same shall be unused for a period of thirty (30) days, or if there should be any failure to comply with and alode by any hydrons or the charter of the Mortgagor, or any stipulations set out in this mortgage, the Mortgagor at its option may write to the Mortgagor at his last known address giving him thirty (30) days in which to rectrly the said default and should the Mortgagor fail to rectrly said default within the said thirty days, the Mortgagor, may, at its option, increase the interest rate on the loan balance for the remaining term of the loan or for a lesser term to the maximum rate per annum permitted to be charged at that time by applicable South Cardina law, or a lesser increase rate as may be determined by the Association. The monthly payments will be adjusted accordingly.
- 11. That should the Mostgagos fail to make payments of principal and interest as due on the promissory note and should any monthly installment become past due for a period in excess of 15 days, the Mostgagoe may collect a "late charge" not to exceed an amount equal to five (5%) per centum of any such past due installment in order to cover the extra expense incident to the handling of such delinquent payments.
- 12. That the Mortgagor berely assigns to the Mortgagoe, its successors and assigns, all the rents, issues, and profits accruing from the mortgaged premises, retaining the right to collect the same so long as the deld herely seconed is not in arrears of payment, but should any part of the principal indebtedness, or interest, taxes, or fire insurance premiums, he past due and unpaid, the Mortgagoe may without notice or further proceedings take over the intelligence, of they shall be occupied by a tenual or tenuate, and collect said rents and profits and apply the same to the indebtedness hereby seconed, without liability to account for anything more than the rents and profits actually collected, less the cost of collection, and any tenual is sutherized upon request by Mortgagoe, than the rents and profits direct to the Mortgagoe, without liability to the Mortgagos, and audified to the contents by the Mortgagoe, and should said premises at the time of such default be occupied by the Mortgagos, the Mortgagos may apply to the Judge of the County Court or to any Judge of the Count of Common Heas who shall be resident or presiding in the county aforesaid for the appointment of a receiver with authority to take possession of said premises and collect such tents and profits, applying said rents, after paying the cost of collection, to the mortgage delt without liability to account for anything more than the rents and profits actually collected.
- 13. That the Mortgagee, at its option, may require the Mortgagor to pay to the Mortgagee, on the first day of each month until the note secured hereby is fully paid, the following sums in addition to the payments of principal and interest provided in said note: a sum equal to the premiums that will next become due and payable on policies of mortgage guaranty insurance (if applicable), fire and other hazard insurance covering the mortgaged property, plus taxes and assessments next due on the mortgaged premises (all as estimated by the Mortgagee) less all sums already paid therefor, divided by the number of months to elapse before one month prior to the date when such premiums, taxes and assessments will be due and payable, such sums to be held by Mortgagee to pay said premiums, taxes and special assessments.
