All that certain piece, parcel, or lot of haid, with all improvements thereon, or hereafter to be constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, on the southeastern side of

Cope Circle, being shown and designated as Lot No. 15 on a plat of Cope Heights made by J. C. Hill, Surveyor, dated December 1, 1962, and recorded in the RMC Office for Greenville County, S. C., in Plat Book III, at page 103, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Cope Circle and the joint front corners of Lots Nos. 15 and 16 and running thence along the common line of said lots, S. 25-05 E. 150 feet to an iron pin; thence along the rear lines of Lots Nos. 18 and 19, N. 64-55 W. 100 feet to an iron pin; thence along the common lines of Lots Nos. 14 and 15, N. 25-05 W. 150 feet to an iron pin on Cope Circle; thence along the southeastern side of Cope Circle, S. 64-55 W. 100 feet to an iron, the beginning corner.
