Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise merdent or apportaining,

TO HAVE AND TO HOLD all and singular the said premises unto the Mortgagoe, its successors and assigns, forever.

And the Mortgagors do hereby bind themselves to WARRANT AND FOREVER DELEND all and singular the said premises unto the Mortgagoe from and against themselves and all other persons lawfully claiming or to claim the same or any part thereof.

PROVIDED, ALWAYS, that if the Mortgagors shall well and truly pay unto the Mortgagore all sums of money evidenced by the aforementioned Agreement, or any and all future advances which Mortgagee shall make to Mortgagors under said Agreement up to the maximum amount shown as the Line of Credit, and shall pay the taxes, insurance premiums and other amounts berein mentioned at the time and in the manner specified in said Note and herein, then these presents and the estate hereby granted shall cease, determine and be void, and thereupon the satisfaction and discharge of this instrument may be completed and executed by the duly appointed and actine manager of the Morteapee.

And the Mortgagors, for themselves and for their heirs and assigns, hereby covenant with the Mortgagee as follows:

- 1. That the Mortgagors shall insure the mortgaged buildings against such hazards, in such amounts and with such carriers as may be approved by the Morteagee, and shall assign the policy or policies of insurance to the Morteagee, and in case they shall at any time fail or neglect so to do, then the Mortgagee may cause the same to be insured in its name, or as interests may appear, and reimburse itself for the premiums and expenses of such insurance, with interest thereon at the maximum local rate payable on the next succeeding instalment date fixed in said Note, and the same shall stand secured by this mortgage.
- 2. That the Morteagors shall pay, as the same may become due, all taxes by whatsoever authority legally imposed on the property hereby mortgaged, and in case they shall at any time neglect or fail so to do, then the Mortgaged may pay such taxes, and reimburse itself for the same with interest thereon at the maximum legal rate, payable on the next billing date established by such Agreement, and that the same shall stand secured by this mortrage.

That upon default in the payment of any instalment of said Agreement, or of any insurance premium, taxes or assessments or in the performance of any of the requirements contained in said Agreement, or of any of the conditions of this mortgage, then the Mortgagee shall have the right to declare the entire amount of the indebtedness secured by such Agreement to be immediately due and payable, and to proceed without notice to enforce the collection of the same, together with interest, attorney's fees and all other amounts secured hereby or permitted by law.

The holder of this mortrage, in any action to forcefore the same, shall be entitled, without regard to the value of the mortraged premises, or the adequacy of any security for the morteage debt, to the appointment one receiver of the reats and profits of the morteaged premises, and such rents and profits are hereby, in the event of any default in the payment of said Agreement seconding to its terms, assigned to the holder of this mortexpe.
- 5. The covenints berein contained shall bind and the benefits shall innie to the respective heirs, executors, administrators, successors and assigns of the parties bereto.

If there be only one morteager, all plurid words berein referring to Morteagers shall be construed in the singular.
