Stuart M. S. Witten and Waynette B. Witten
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Eight Thousand Three Hundred Fifty and no/100-----DOLLARS

(\$38,350.00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 78 on plat of Devenger Place, Section 3, recorded in Plat Book 5P at page 99 and having the following courses and distances:

BEGINNING at an iron pin on Hedgewood Terrace, joint front corner of Lots 78 and 79 and running thence S. 4-18 W. 150 feet to an iron pin, joint rear corner of said lots; thence with the rear line of Lot 73, N. 85-42 W. 91 feet to an iron pin, joint rear corner of Lots 77 and 78; thence with joint line of said lots, N. 4-18 E. 150 feet to an iron pin on Hedgewood Terrace; thence with said Terrace, S. 85-42 E. 91 feet to an iron pin, the point of beginning.

Being the same property conveyed by Devenger Road Land Company by deed recorded December 2, 1977.
