WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

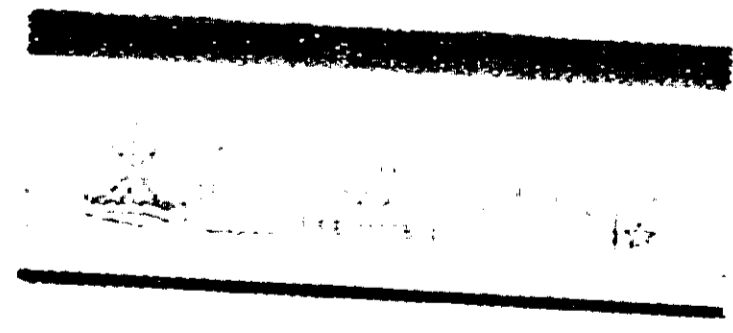
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 25 on Plat Entitled Section 1, Powderhorn, dated July 26, 1973, most recently revised March 1, 1974, prepared by Piedmont Engineers and Architects, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4X, at Page 95 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the western side of Rainwood Drive at the joint front corner of Lots 25 and 26 and running thence with the joint line of said lots N. 85-25 W. 150 feet; thence S. 4-06 W. 100 feet; thence N. 83-05 E. 46.10 feet to a point; thence N. 86-01 E. 106 feet to a point on Rainwater Drive; thence with said street N. 3-59 E. 75.0 feet to a point at the joint rear corner of Lots 25 and 26 to the point and place of beginning.
