MORTGAGE OF REAL ESTATE

All that certain piece, parcel, or let of land, with all improvements thereon, or bereafter to be constructed thereon, situate, bing and being in the State of South Carolina, County of Greenville, on the eastern side of Brook Glenn Road and being known and designated as Aot No. 104 of BROOK GLENN GARDENS Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book JJJ at Page 85 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Brook Glenn Road, joint front corner of Lots 103 and 104 and running thence with Lot 103, N.60-17 E. 150 feet to an iron pin at the joint rear corner of Lots 103 and 104; thence with the rear lines of Lots 116 and 115, S.29-43 E. 110 feet to an iron pin at the joint rear corner of Lots 104 and 105; thence with Lot 105, S.60-17 W. 150 feet to an iron pin on Brook Glenn Road; thence with said Road, N.29-43 W. 110 feet to the point of beginning.
