and Lois J. Creekmore (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

(\$ 43,150.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Cannon Circle, Greenville County, South Carolina, being shown and designated as Lot 84 on a Plat of PINE BROOK FOREST, recorded in the RMC Office for Greenville County in Plat Book 4-X, at Page 48, and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on the western side of Cannon Circle, at the intersection of Cannon Circle and Rose Wood Drive, and running thence with Cannon Circle, N 25-51 W, 120 feet to an iron pin, joint rear corner of Lots 84 and 85; thence with the common line of said Lots, S 73-25 W, 155 feet to an iron pin; thence with the common line of Lots 83 and 84, S 16-35 E, 140 feet to an iron pin on the northern side of Rose Wood Drive; thence with said Rose Wood Drive, N 73-25 E, 155 feet to an iron pin; thence continuing with the curve of Rose Wood Drive, S 36-15 W, 28 feet to an iron pin, the point of beginning.
