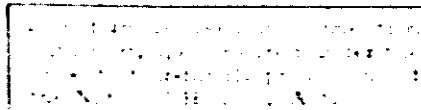

TO ALL WHOM THESE PRESENTS MAY CONCERN:

hereinafter called the Mortgagor (send his greetings)

WHEREAS, the Mortgagor is well and truly indebted unto **Collateral Investment Company**

organized and existing under the laws of **Alabama** hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are in-
corporated herein by reference, in the principal sum of **Fifteen Thousand Four Hundred Fifty and No/100**
Dollars (\$ 15,450.00) with interest from date at the rate
of **eight and one-half** per centum **8 1/2** per annum until paid, said principal
and interest being payable at the office of **Collateral Investment Company**
in **Birmingham, Alabama**

or at such other place as the holder of the note may designate in writing, in monthly installments of **One Hundred**
Eighteen and 81/100 Dollars (\$ 118.81),
commencing on the first day of **January** 19 **78**, and on the first day of each month thereafter until
the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid,
shall be due and payable on the first day of **December, 2008**.

NOT KNOWN ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mort-
gagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the
receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does
grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following described real
estate situated in the County of **Greenville**,
State of South Carolina

**ALL that piece, parcel or lot of land, with buildings and improvements thereon, situate,
lying and being in Greenville County, South Carolina, on the northerly side of Prancer
Avenue and being shown and designated as Lot No. 277 on plat of Pleasant Valley Subdivision
recorded April 1946 in Plat Book P at page 92 and according to said plat, having the
following metes and bounds, to-wit:**

**BEGINNING at an iron pin on Prancer Avenue at the joint front corner of Lots 278 and 277
and running thence N. 0-08 W. 160 feet to a point; thence running N. 89-52 E. 60 feet to
an iron pin; thence running S. 0-08 E. 160 feet to a point on Prancer Avenue at the joint
front corner of Lots 277 and 276; thence along Prancer Avenue S. 89-52 W. 60 feet to the
point of beginning.**

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in
any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom,
and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in
connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns
forever

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple ab-
solute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises
are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and for-
ever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all per-
sons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at
the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal
to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior
to maturity; provided, however, that written notice of an intention to exercise such privilege is given at least thirty
(30) days prior to prepayment.
