SHERRY A. THACKSTON (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FORTY THOUSAND and NO/100-----DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 288 DEVENGER PLACE, SECTION 8, as shown on plat thereof prepared by Galton & Neves, Co., Greenville County, S.C. in Plat Book 5P, Page 4, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Devenger Road at the joint front corner of Lot Nos. 287 and 288 and running thence S. 86-11 W, 100 feet to an iron pin; thence N 3-49 W, 200 feet to an iron pin; thence N 66-11 E, 100 feet to an iron pin at the rear joint corner of Lot Nos. 287 and 288; thence along the line of lot No. 287 S 3-49 E, 200 feet to an iron pin, the point of beginning.
