WHEREAS, I, ISABELLA NORRIS

hereinafter referred to as Mortgagor) is well and truly indebted unto THE GREENVILLE COUNTY REDEVELOPMENT AUTHORITY

hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of FIVE THOUSAND AND NO/100-----

in 180 equal monthly installments in the amount of Twenty-Nine and 92/100 (\$29.92) each until paid in full with the first payment being due and payable on February 15, 1978 and each month thereafter until paid in full.

with interest thereon from date at the rate of One (1%) per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, described as follows:

BEGINNING at an iron pin on the eastern side of Alice Avenue at corner of lot now or former owned by Bertha Collins; thence with the line of said lot N. 89-53 E. 119.2 feet to an iron pin in line of property now or formerly owned by Goodlett; thence with line of said property N. 13-41 W. 50 feet to iron pin; thence S. 89-53 W. 118.8 feet to an iron pin on Alice Avenue; thence with eastern side of said avenue S. 13-15 E. 50 feet to pin.
