WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ----- Nineteen Thousand and no/100-----DOLLARS

(\$ 19,000.00 ) as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is fifteen years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the northeast side of DuPont Drive and being known and designated as Lot No. 148 of Isaqueena Park as shown on a plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book P at Pages 130 and 131, and being more particularly described according to a plat prepared by C.C. Jones, Engineer, as follows:

BEGINNING at an iron pin on the northeast side of DuPont Drive at the joint front corners of Lots Nos. 147 and 148, and running thence with the joint lines of said lots, N. 20-40 E. 166 feet to an iron pin; thence N. 45-51 W. 71.3 feet to an iron pin, rear corner of Lot No. 149; thence with the line of said lot, S. 23-42 W. 193.9 feet to an iron pin on the northeast side of DuPont Drive; thence with said drive, S. 66-06 E. 45 feet to an iron pin; thence continuing with said drive, S. 71-06 E. 30 feet to the beginning corner.
