ALL that piece, parcel or lot of land situate, lying and being in Greenville County. South Carolina on the northern side of Easley Bridge Road, known and designated as a portion of lot No. 131 of Camilla Park No. 4, a plat of which is recorded in Plat Book W, at Fage 117 and a portion of Lot No. 6 of a subdivision of the estate of Wills Resemend, as surveyed February, 1912, by F.
