All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 10 on plat of Devenger Place, Section 7, recorded in Plat Book 5P at page 3 and having the following courses and distances, according to said plat:

BEGINNING at an iron pin on Richfield Terrace, joint front corner of Lots 10 and 11 and running thence with joint line of said lots, S. 16-00 W. 166.3 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot 10, N. 59-18 W. 130 feet to an iron pin, joint rear corner of Lots 9 and 10; thence along the joint line of said lots, N. 33-56 E. 150.6 feet to an iron pin on Richfield Terrace; thence with Richfield Terrace, S. 66-53 E. 80 feet to the point of beginning.
