MORTGAGE RELEASE

Ogle, and running thence with the southeastern side of Hammett Road, N. 26-12 E., 146.39 feet to an iron pin; thence S. 46-09 E., 285.23 feet to an iron pin; thence S. 30-21 W., 212.0 feet to an iron pin in the line of property now or formerly belonging to Ogle; thence along the Ogle line, N. 35-11 W., 321.1 feet to an iron pin on the southeastern side of Hammett Road, the point of BEGINNING.
